JE T'AIME, NINTENDO SWITCH CONTEST OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST.

Purchase will not improve odds of winning.

The *Je t'aime, Nintendo Switch* Contest (the "Contest") is sponsored by Nintendo of Canada Ltd., 2925 Virtual Way, Vancouver, BC V5M 4X5, Canada ("Sponsor").

Eligibility: Contest is open only to individuals who are legal residents of Quebec, province of Canada who are at least 13 years of age at the time of entry. Directors, officers and employees of Sponsor, and any of its respective affiliate companies, subsidiaries, agents, professional advisors, and advertising and promotional agencies, members of the Contest jury and persons with whom each are domiciled, including immediate family, are not eligible to win any prizes.

Contest Period: The entry period for the Contest ("Entry Period") begins Friday, February 1, 2019 at 12:00 pm and ends on Monday, February 18, 2019 at 11:59 pm (all times in these Official Rules are Eastern Time). All entries must be received by Sponsor during the Entry Period.

How to Enter: Limit one entry per person. To enter, you must first be logged in as a registered user of Twitter or Instagram. (If you are not a registered Twitter or Instagram user, you can register for free at www.twitter.com or www.instagram.com.) While you are logged in to your Twitter or Instagram user account, you must do the following during the Entry Period:

- (1) Tweet or post your artwork, photo or video explaining why you like the Nintendo Switch system. (the "Entry")
- (2) Use the following hashtags to denote your submission #JetaimeNintendoSwitch #ConcoursNintendo. You may add additional hashtags or tags after this language, but the provided hashtags <u>must</u> appear at the beginning of your post or tweet.

General Guidelines: All submissions must adhere to the following guidelines:

- Your Entry must be suitable for general audiences and not be offensive, obscene, or illegal, or violate the rights of others. In addition, your Entry must not violate any policies or terms of Twitter or Instagram.
- Be safe. Do not engage in any dangerous activities to make your artwork. Do not harm (or pretend to harm) yourself or anyone else in your Entry.
- Your Entry must be an original, non-commercial work of your own creation. Do not submit professional content. Contest Rules: On or around Tuesday, February 19, 2019 a random draw will be held at the Nintendo of Canada head office to determine 25 finalists. One winner will be selected based on what the judges find, in their sole discretion, to be the most apt, original, and interesting Entry based on the following judging criteria ("Judging Criteria"):

- a) **Originality** the overall creativity and originality of the Entry.
- b) **Spirit** how well the Entry encompasses your enthusiasm for Nintendo Switch and the *Je t'aime, Nintendo Switch* theme.

The judging panel will assign points for each of the Judging Criteria. Each of the Judging Criteria will have the same maximum possible points that can be assigned by the panel, such that each of the Judging Criteria will be weighted equally. The sum of the points for each Entry will be the Entry's total score for the Contest. In the unlikely event of a tie, the winner will be deemed to be the entrant with the highest number of points in the following judging criteria: Spirit: how well the Entry encompasses your enthusiasm for Nintendo Switch and the Contest theme. The potential winner will be notified by direct message on or about February 19th, 2019.
